

A new major update is now available for EPICS V9. This includes a number of important fixes and **8 new wishlist items**, 4 of which were in the top 10!

Please remember to use the <u>V9 Major Update Procedure</u> when performing this update.


Below is a detailed description of the major update:

* EPICS wishlist item

• *(#3) You now have the ability to Void a stock ticket rather than delete it from the Maintain Stock Inventory screen. This will set the status to 'X' and provides you with a history of stock management.

- Fix: When scanning any ticket that is part of a master ticket on the Enhanced Shipping Module, all tickets that are part of that master ticket will also be scanned.
- Fix: If it is in the item's routing, update pack to outside departments correctly when packing multiple identical tickets on same date.
- Fix: Reports menu: Maintain window state and keep form in front when you click the "View Report Details" button.
- Fix: Correct problem with column locking and price locking on SOEntry and Quote screens.
- Fix: Improve calculation of PricePerWt for per/item charges on order entry and quote screens.
- Fix: Eliminate Crystal memory leak when printer selection is turned on.
- Fix: Do not increase remaining weight for PULLED department when shipping tickets that were pulled as ready-to-ship.
- Fix: Correct rounding of total billet weight on production screen when billet weight/length includes more than 3 decimal places.

For testing purposes, we will provide the sample data so that all you have to do is open a web browser and login with the user and password that we provide, and give it a try! We are making progress on our development of an **Outside Processor App** (which you can also read about in <u>August's Newsletter</u>). The Outside Processor App is intended to help improve communication and visibility between the extruder and the vendor. Would you send a <u>quick email</u> and let us know what features would most likely benefit you in an application like this?

We are also in the beginning process of developing an Order Entry App.

The concept for the **Order Entry App** is to allow customers to login to an online order screen where they will be able to select from a dropdown of existing parts, with the ability to change the finish, length, alloy and temper if needed. This application is in the very early stages of development, so we would greatly appreciate <u>your thoughts</u> on what you would like an application like this to include.

We want to take full advantage of cloud computing capabilities, so look for more information regarding web applications coming from us soon. This will no doubt be a heavily discussed topic in the upcoming 2016 EPICS User Conference.
